WAIVER & RELEASE OF ALL CLAIMS & ASSUMPTION OF RISK

- I understand that Lloydminster Muck Run presents challenging obstacles for my child.
- My child is age **5 years or older** and **I, as parent/guardian, will be present** at this event.
- I agree not to let my child participate unless medically able.
- I agree to obey all civil and criminal laws at all times.
- I am aware of all risks associated with my child participating in the Lloydminster Muck Run, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.
- I agree that Lloydminster Muck Run and Lloydminster Region Health Foundation are not responsible for any personal items or property that are lost or stolen in the gear check area.
- I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to us as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.
- I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.
- I grant permission to Lloydminster Muck Run and Lloydminster Region Health Foundation, and all affiliates, sponsors, and assign to use any photographs, motion pictures, recordings or any other record of this event for any purpose including but not limited to promoting, advertising and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of Lloydminster Muck Run and Lloydminster Region Health Foundation.
